Guided Maine Hunt Release/Assumption of Risk

Please read carefully before signing as this constitutes a release of liability
and a waiver of certain legal rights

I, _____, in consideration of participating in the activities of this hunt hereby acknowledge the following:

This hunt offered by Canoe the Wild [hereinafter also known as Releasees] may take place in a remote wilderness setting and involves activities with numerous inherent risks, hazards and dangers for anyone that cannot be eliminated. I understand that participation in this hunt requires and that I have sufficient physical conditioning and a degree of skill and knowledge in hunting and the use of firearms. The inherent risks of this hunt include but are not limited to: risk from handling firearms and ammunition and being in the vicinity of others using the same, interactions with nature and wild animals in rough terrain, potential inclement weather, riding in vehicles in off-road locations, and from use of tree stands. In the event of an injury or illness medical facilities may be several hours away from remote settings and evacuation may be required by helicopter, airplane, etc. Participants are responsible for any additional costs incurred for evacuation as the result of injuries or illness. I recognize the danger of being under the influence of substances while participating in these activities and will refrain from using any substances in a manner that would affect my ability to respond to dangers incurred on this hunt.

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, and assume full responsibility for my participation in such inherently risky activities. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS Canoe the Wild.**, its guides and other agents and/or employees, from any and all claims, demands, losses, and liability arising out of or related to any **INJURY, DISABILITY OR DEATH** I may suffer, or loss or damage to person or property, **WHETHER ARISING FROM ANY NEGLIGENCE, ACT OR OMISSION OF THE RELEASEES**, to the fullest extent permitted by the laws of the State of Maine.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, AGREE TO MY OWN RESPONSIBILITIES, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT. I FURTHER ACKNOWLEDGE THAT PARTICIPATION IN THIS TRIP IS A VOLUNTARY ACTIVITY AND NEITHER A PUBLIC SERVICE NOR A PRACTICAL NECESSITY AND I AM FREE TO DECLINE TO PARTICIPATE. I HEREBY AGREE TO PARTICIPATE.
